Sub.: Filling up of vacancies in the Post of Chageman (Tech & Non-Tech) in terms of SRO-13E dt. 04.05.1989 / SRO-191 dated 28.11.1994 / SRO-66, dated 27.05.2003 through Limited Departmental Competitive Examination for vacancies arises upto 01.01.2020.

As per provisions of SRO-13E dated 04.05.1989/SRO-191 dated 28.11.1994 / SRO-66 dated 27.05.2003 and based on the orders from Ordnance Factory Board, it has been decided to hold a Limited Departmental Competitive Examination for filling up the post of Chageman (Technical / Non-Technical).

2. The salient features of the LDCE will be as under:-

- i. 25% of the vacancies in the Chageman (Tech) will be filled in by LDCE from amongst persons in all categories of Skilled workers or equivalent and above with 2 years' experience in the grade. Two years' experience will be computed with reference to the last date of receipt of application.
- ii. 25% of the vacancies in the grade of Chageman (Non-Tech) will be filled up by LDCE from amongst Lower Division Clerks or equivalent and above with 2 years' experience in the grade. Two years' experience will be computed with reference to the last date of receipt of the application.

Eligibility :-

OFB vide letter No. 2982/LDCE/CM(T&NT)/2020/PER/GB dated 24.04.2020 has clarified that while ascertaining the eligibility of the candidates in LDCE to the posts of Chageman (Non.Tech/Stores), Chageman (Tech/Mech.), Chageman (Tech/Chem.) and Chageman (Tech/Civil) where SRO prescribed Degree (i.e., B.Sc., B.A., etc. variously) from a recognized University as eligible qualification, where UGC guidelines with regard to minimum qualification required at entry level of the degree programmes and minimum duration of the degree programmes. **"The Gazette notification clearly specified requirement of 10+2 as entry level qualification for undertaking Degree Courses and minimum duration of the degree programmes is 3 years."**

CM (T/Mech) :-

Must possess three years Diploma or equivalent qualification certificate in the respective field duly affiliated by AICTE. Person(s) in all categories of skilled workers or equivalent with 2 years' experience in the grade. *

CM (T/Civil) :-

Must possess three years Diploma or equivalent qualification certificate in the respective field duly affiliated by AICTE. Person(s) in all categories of skilled workers or equivalent with 2 years' experience in the grade. *

CM (T/Chemical) :-

Must possess B.Sc., Degree with General Chemistry as one of the major subjects. (OR) Three years' Diploma or equivalent exams / qualification in respective field duly affiliated by AICTE. Person(s) in all categories of skilled workers or equivalent with 2 years' experience in the grade.*

CM (NT/Stores):-

Must possess Graduate Degree in Engineering, Technical, Humanities, Science, Commerce, Law etc. from a recognized University. Lower Division Clerks or equivalent and above with 2 years' experience in the grade. *

* : Two years of experience will be computed with reference to the last date of receipt of the application.

A candidate must possess the required educational qualification on the last date of receipt of the application. Further a candidate who has appeared in the final year of the examination of the required qualification, before the last date of receipt of the application may also apply. But he / she must produce the pass certificate / documents before the date of written examination for selection along with an undertaking that his / her selection will be subject to the verification of Certificate / documents for suitability of required qualification.

SELECTION:- Will be on the basis of the rank in the written / Departmental Competitive Examination and available vacancy in the respective trade / discipline and in the respective category.

The number of vacancies available in EFA for filling up by LDCE will be as under:-

Tentative Time Schedule:- Exact time schedule for holding examination will be notified later on.

The examination will be held at OFIL, Avadi.

How to apply and other conditions:- Eligible Factory candidates desirous to attend the competitive examination may apply to The General Manager, Engine Factory Avadi.

Fees:- A sum of Rs. 100/- (Rupees One Hundred only) (except SC/ST candidates) should be paid to the Cashier, EFA against Cash Receipt.

The minimum pass marks in each individual subject shall be 35% while the minimum qualifying marks in aggregate shall be 40%. Candidates who qualify in the written examination will be listed in the order of merit. For SC/ST candidates competing against reserved vacancies, the minimum qualifying marks in each subject shall be 30% and minimum qualifying marks in aggregate shall be 35%, if adequate number of SC/ST candidates is not available in the general standard.

There shall be no interview for filling the vacancies in the post through LDCE.

The eligible Factory Employees desirous to appear for the Limited Departmental Competitive Examination may submit their application through proper channel to reach Admin Section on or before 15/06/2020 along with Cash Receipt and a set of 2 Admission letter and other enclosures of attested copies of certificates. The application format and admission letter (Blank) should be as per the enclosure.

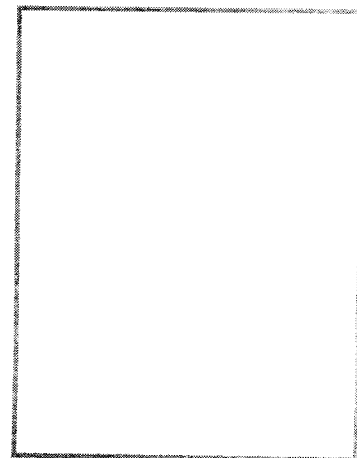
